Fall 2023 Financial Aid

Students who expect to start classes on August 28th (Full Semester, Term 1, and Session 1) should review the information below:

April 1: Priority date* for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.

- August 14: Consortium Agreement Deadline.
- August 24: Last day to register for FS, T1, and S1 classes.
- August 25: FS, T1 and S1 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be established. 9:00 am deadline for payments and letters of credit.
- **September 3:** Book Voucher Deadline for students with a FS, T1, or S1 start date.
- **September 19:** For students with a semester start date of August 28th (FS, T1, and S1), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on October 9th (Session 2) should review the information below:

- August 14: Consortium Agreement Deadline.
- **September 1: Priority date*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- October 5: Last day to register for S2 classes.
- October 6: S2 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be established. 9:00 am deadline for payments and letters of credit.
- October 15: Book Voucher Deadline for students with a S2 start date.
- October 24: For students with a semester start date of October 9th (S2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on October 30th (Term 2) or expect to start classes on November 20th (Session 3) should review the information below:

- August 14: Consortium Agreement Deadline.
- September 1: Priority date* for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- October 26: Last day to register for T2 and S3 classes.

- October 27: T2 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be stablished. 9:00 am deadline for payments and letters of credit.
- November 5: Book Voucher Deadline for students with a T2 start date.
- **November 17:** If anticipated aid is not reflected on your account for S3 courses, alternative methods of payment must be established. 9:00 am deadline for payments and letters of credit.
- November 26: Book Voucher Deadline for students with a S3 start date.
- **November 20:** For students with a semester start date of October 30th (T2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*
- **December 5:** For students with a semester start date of November 20th (S3), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*
- * If the semester priority processing date is missed, your application will still be accepted and processed, however, we are unable to guarantee that your aid will be posted to your account by the bill due date. You can still take advantage of paying your tuition by utilizing the COSC payment plan in order to meet the College's payment deadline for tuition and fees.
