Fall 2021 Financial Aid

Students who expect to start classes on August 23rd (Full Semester, Term 1, and Session 1) should review the information below:

April 1: Priority date* for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.

- August 9: Consortium Agreement Deadline.
- August 19: Last day to register for FS, T1, and S1 classes.
- August 20: FS, T1 and S1 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be established.
- August 29: Book Voucher Deadline for students with a FS, T1, or S1 start date.
- **September 14:** For students with a semester start date of August 23rd (FS, T1, and S1), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on October 4th (Session 2) should review the information below:

- August 9: Consortium Agreement Deadline.
- September 1: Priority date* for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **September 30:** Last day to register for S2 classes.
- October 1: S2 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be established.
- October 10: Book Voucher Deadline for students with a S2 start date.
- October 25: For students with a semester start date of October 4th (S2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on October 25th (Term 2) or expect to start classes on November 15th (Session 3) should review the information below:

- August 9: Consortium Agreement Deadline.
- **September 1: Priority date*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- October 21: Last day to register for T2 and S3 classes.

- October 22: T2 courses dropped for non-payment (final deadline). If anticipated aid is not reflected on student billing account, alternative methods of payment must be stablished.
- October 31: Book Voucher Deadline for students with a T2 start date.
- **November 12:** If anticipated aid is not reflected on your account for S3 courses alternative methods of payment must be established.
- November 21: Book Voucher Deadline for students with a S3 start date.
- **November 15:** For students with a semester start date of October 25th (T2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*
- **December 1:** For students with a semester start date of November 15th (S3), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

^{*} If the semester priority processing date is missed, your application will still be accepted and processed, however, we are unable to guarantee that your aid will be posted to your account by the bill due date. You can still take advantage of paying your tuition by utilizing the COSC payment plan in order to meet the College's payment deadline for tuition and fees.
