

## Summer 2022 Financial Aid

Students who expect to start classes on Monday, May 23rd (Term 1 and Session 1) should review the information below:

- **May 1: Priority date\*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 10:** Consortium Agreement Deadline.
- **May 19:** Last day to register for Term 1 and/or Session 1 classes with no late fee.
- **May 20:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **May 23:** Term 1 and Session 1 classes begin.
- **May 29:** Book Voucher Deadline.
- **June 14:** For students with a semester start date of Monday, May 23<sup>rd</sup> (Term 1 and Session 1), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on Monday, June 20th (Term 2) should review the information below:

- **May 1: Priority date\*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 10:** Consortium Agreement Deadline.
- **June 16:** Last day to register for Term 2 with no late fee.
- **June 17:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **June 20:** Term 2 classes begin.
- **June 26:** Book Voucher Deadline.
- **July 12:** For students with a semester start date of Monday, June 22<sup>nd</sup> (Term 2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on Monday, July 11<sup>th</sup> (Session 2) should review the information below:

- **May 1: Priority date\*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 10:** Consortium Agreement Deadline.
- **June 30:** Last day to register for Session 2 classes with no late fee.
- **July 8:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **July 11:** Session 2 classes begin.
- **July 17:** Book Voucher Deadline for students with a Session 2 start date.
- **July 25:** For students with a semester start date of Monday, July 5th (Session 2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

\* If the semester priority processing date is missed, your application will still be accepted and processed, however, we are unable to guarantee that your aid will be posted to your account by the bill due date. You can still take advantage of paying your tuition by utilizing the COSC payment plan in order to meet the College's payment deadline for tuition and fees.
