Students who expect to start classes on Monday, June 5<sup>th</sup> (Term 1 and Session 1) should review the information below:

- May 1: Priority date\* for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- May 22: Consortium Agreement Deadline.
- June 1: Last day to register for Term 1 and/or Session 1 classes.
- **June 2:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- June 5: Term 1 and Session 1 classes begin.
- June 11: Book Voucher Deadline.
- **June 27:** For students with a semester start date of Monday, June 5th (Term 1 and Session 1), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

- May 22: Consortium Agreement Deadline.
- July 13: Last day to register for Session 2 classes.
- **July 14:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- July 17: Session 2 classes begin.
- July 23: Book Voucher Deadline for students with a Session 2 start date.
- **August 8:** For students with a semester start date of Monday, July 17th (Session 2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*
