Students who expect to start classes on Monday, May 20th (Term 1 and Session 1) should review the information below:

- **May 1: Priority date*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 6:** Consortium Agreement Deadline.
- **May 16:** Last day to register for Term 1 and/or Session 1 classes.
- **May 17:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **May 20:** Term 1 and Session 1 classes begin.
- **May 26:** Book Voucher Deadline.
- **June 11:** For students with a semester start date of Monday, May 20th (Term 1 and Session 1), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on Monday, June 17th (Term 2) should review the information below:

- **May 1: Priority date*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 6:** Consortium Agreement Deadline.
- **June 13:** Last day to register for Term 2.
- **June 14:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **June 17:** Term 2 classes begin.
- **June 23:** Book Voucher Deadline.
- **July 9:** For students with a semester start date of Monday, June 17th (Term 2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

Students who expect to start classes on Monday, July 8th (Session 2) should review the information below:

- **May 1: Priority date*** for submitting missing documents. Priority consideration of financial aid resources are given to students who apply ON-TIME. After the deadline, financial aid awards will continue to be made, but all funding sources may not be available.
- **May 6:** Consortium Agreement Deadline.
- **July 4:** Last day to register for Session 2 classes.
- **July 5:** Courses dropped for non-payment. If anticipated aid is not reflected on student billing account, alternate methods of payment must be established.
- **July 8:** Session 2 classes begin.
- **July 14:** Book Voucher Deadline for students with a Session 2 start date.
- **July 30:** For students with a semester start date of Monday, July 8th (Session 2), financial aid disbursements will begin after confirmation of attendance. *Please note that refunds of financial aid will be issued 5-10 business days after this date.*

* If the semester priority processing date is missed, your application will still be accepted and processed, however, we are unable to guarantee that your aid will be posted to your account by the bill due date. You can still take advantage of paying your tuition by utilizing the COSC payment plan to meet the College's payment deadline for tuition and fees.
